BACKGROUND/JUSTIFICATION:

An architect is needed to design renovations to the Mecklenburg County Sheriff's Office Administrative Services Building (formerly the Work Release & Restitution Center) located at 901 Elizabeth Avenue, for the purpose of relocating Sheriff's Office Headquarters and various divisions into the Administrative Services Building. Full design services will be required including a facility

code assessment, program verification, design, construction documentation, bidding, and construction administration.

PROCUREMENT BACKGROUND:

A Request for Qualifications (RFQ) was advertised on July 27, 2023, in the Charlotte Observer, the Charlotte Post, and the State of North Carolina Interactive Purchasing System web site. The selection of the consulting firms followed NC General Statute 143-64.31, which prescribes a qualifications-based selection process.
